Matthew gives an update on relocation out-of-state; we thank him for serving both on vestry; his tenure was short but his contributions were integral, especially as the leader of St. John's Requiem and Renaissance team.

Matthew recommended Jonathan Cureton to serve out his remaining vestry term and made a motion for same. Correne seconds, and the vestry vote is unanimous.

Requiem and Renaissance (M. Green)

This retreat is July 14 & 15 at Mercy Center; Matthew has notified Canon Whitney of plans, and Rev. Nancy has received feedback.

Committee updates

- Buildings and Grounds (M. Tschomakoff, email update)
 - Extra meeting coming up in July
 - Grant of 10K received toward electrical upgrades; bids are averaging 12K
 - Receiving bids to redo plaster in sanctuary; decision was made to put off plaster repair until next year for budget purposes.
 - Sexton will repair plaster underneath parish hall windows and assess church sign on front lawn.
 - Gas usage and costs are being monitored throughout Sanctuary and parish offices.
- Fundraising/Stewardship (A. Balsamo, M. Green)
 - Matthew created, and Ann edited, a fundraising calendar

- Playbook creation is in progress and will dovetail with a calendar for all steps needed to coordinate events.
- Will need to coordinate with communications committee in order to prepare and publish calendar and events.
- Need stewardship team in place by August as well as overall fundraising team.
- Vestry discussed potential for 2023-24 concerts and approaching congregants for assistance with teams/committees; how to leverage talents/new folks or even 3rd party folks not necessarily affiliated with STJ, eg. Welcome Neighbor and Pride STL
- Nancy will talk with Pride STL

Action calendar

- Vestry unanimously votes to approve proposed events calendar for remainder of 2023, with Matthew Green motioning to approve, seconded by Liam Clements.

Financials for May (N. Emmel Gunn)

- We are where we should be at 41% income
- Still waiting on monies owed from Brown Paper Tickets
- Grant line item is higher bc of 10K received for roof repair
- Peace Meal income at 42%
- Total income 45%

Expenses

- Liturgy expenses slightly high
- Christian Education monies not yet handed out to spenders
- General plant upkeep is at 62% of expenditures
- Keith tracking usage of gas as denoted in B&G report; all other expenses normal
- We have put in a claim with building insurance for repaired bullet hole in window
- Rental occupancy at 61%
- We're responsible with income, people are making pledges and plate offerings, but high expenses mean we are negative \$2,500.
- The church has \$51,000 in the bank
- Peace Meal \$4,900 in bank; enough to operate through 2023

Priest's Update

- Collaborations with Oak Hill and Compton Heights continue
- Community listening—next event, perhaps on early Saturday afternoons
- Vestry discussed donating to MO Jobs with Justice for a Diocesan-wide Pride ad. R. McCool moved to approve, C. Murphy seconded, and vestry approves 4-1.
- Adult confirmation dates
- Requested diocesan assistance for 2024
- Mini-hiring committee to replace Tracey as organist. Job announcement created and sent out to guild of organists, MO diocese, and Indeed. One applicant so far.
